# Legislative Committee Update

This February over 50 Dental Hygienists, students and Senators gathered for the NDHA legislative breakfast! This annual event is a great opportunity to build relationships with our lawmakers and establish ourselves as dental subject matter experts that they can rely on when making decisions that impact our profession. This legislative session has been very active with several Bills pertaining to dentistry. Below is a summary and status report for these Bills as of mid March.

**LB824**: DDH Compact Bill has been advanced from Committee and is on General File, without a priority designation. This Bill would make license portability for dentists and hygienists in participating states available via compact privileges. Virginia passed their Compact Bill into law on March 8th, marking the 5th state to enact the Compact. Two more states must pass legislation to activate the compact in all participating states.

**LB1138**: Has been added onto LB1215, which is the HHS Committee Priority Bill and is currently on Select File. This Bill provides an exemption to the general electronic prescribing requirement for controlled substances for prescriptions issued by a prescriber who issues FEWER than 50 prescriptions for controlled substances in one calendar year.

**LB834**: Is a Speaker Priority Bill and is currently sitting on Select File. The Bill would establish requirements for a resident dental license and recognize the ADEX exam for this specific license type.

**LB358**: This Bill has carried over from last year and is in Final Reading. This Bill would increase dental reimbursement rates by 25%, infusing about \$20M of state and federal funds into the Medicaid dental program. Advancement of the Bill is contingent upon passing of the State budget and could be subject to amendment depending on the budget. The following Bills are still in Committee with no priority designation:

**LB1015**: This Bill would establish loan repayments to dentists who see a disproportionate amount of Medicaid patients.

**LB1387**: This Bill would put water fluoridation measures on the ballot. NDHA testified in opposition to this Bill at the hearing.

**LB1110**: This Bill regards Dental Loss Ratio requirements in dental insurance, which refers to the insurance premium revenue that is spent on patient care instead of operating costs. This Bill aims to set a minimum ratio that dental plans must meet, with a corresponding rebate requirement for plans spending less than that minimum.
